

# SPEC SHEET & WARRANTY

## Limited Warranty

### **BLU PUFFIN DESIGNS.**

You have made an investment in lasting quality that will afford you years of enjoyment and comfort. Please read the terms of the BLU PUFFIN DESIGNS.-Limited Warranty coverage.

**BLU PUFFIN DESIGNS** products are guaranteed to the original purchaser to be free of defects in materials and workmanship for the length of time specified. This warranty applies under conditions of normal uses and does not apply to defects resulting from negligence, misuse, accident or abuse. The purchaser will be responsible for packing and shipping cost to and from the factory or service depot. This warranty does not extend the manufacturer's warranty on any of the components used. BLU PUFFIN DESIGNS. will not honor any other warranty expressed or implied. To obtain benefits of this warranty, you should contact the dealer from whom you purchased the merchandise. BLU PUFFIN DESIGNS obligation under this warranty is limited to repairing or replacing any parts of the product found to be defective in material or workmanship, within the following criteria:

### CUSHION components

- Five (5) Years FORM FURNITURE FACTORY seating consists of high quality foam cut to precise specifications and wrapped in layers of polyester fiber for exceptional comfort. Cushions are warranted against loss of resiliency. The loss of resiliency should not be confused with a slight softening and flattening of the polyester fiber and foam that will occur as a result of normal usage and aging.

### FRAMES & SPRINGS

- Lifetime (10 year) Made of engineered hardwood, the frame construction and support system are warranted against breakage due to defective material or workmanship for 10 year period.

### FABRIC & VINYL

- One (1) Year Upholstery fabrics are warranted by the original manufacturer against defective material or workmanship for one year. This warranty does not cover fading, pilling\*, or shrinkage and is not valid where there is evidence of heavy soiling, exposure to pets or abuse. Fabric damage or failure due to chemical treatment or improper cleaning is also excluded from this warranty. Proper cleaning instructions may be obtained from your BLU PUFFIN DESIGNS. dealer.

\* Pilling is characteristic of some upholstery fabrics which results in excess fiber coming off the surface of the material. This results in small balls or pills of fiber on the surface of the fabric. This condition is not warranted by the fabric mills because it is not viewed as a defect. It is simply excess material being released, which is comparable to fuzzing seen on new carpet or clothing, such as sweaters. The concern is the assumption that the fabric will come apart or disintegrate leaving a hole or 'bald' spot. In fact, the pilling will only persist until the excess fiber is gone and then it will stop. The recommendation during this process is to shave the surface of the fabric with a sweater shaver to remove the pills and restore the appearance of the fabric surface. This may need to be repeated until the surface pilling lessens and eventually stops. All work done under this warranty must be approved in writing in advance

BLU PUFFIN DESIGNS.reserves the right to perform all repairs at the factory in Calgary, Alberta. Freight costs to and from the factory are the responsibility of the end customer.

Please retain your original sales receipt and the printed warranty attached to your new furniture to substantiate your claim in the event warranty service is required.

### WARRANTY PROCEDURE

To initiate a BLU PUFFIN DESIGNS service claim please see below:

1. Client should contact dealer.
2. Dealer should inspect and establish the need for warranty service prior to contacting customer service at BLU PUFFIN DESIGNS
3. If service is required, BLU PUFFIN DESIGNS.Customer Service will issue a return authorization number. Shipping charges will be the responsibility of the consumer.
4. Upon confirmation by NANSEN GROUP INC. customer service that the warranty claim is valid, BLU PUFFIN DESIGNS will repair or replace the product at our option and return the product to the dealer, freight prepaid.
5. If BLU PUFFIN DESIGNS service department cannot verify a defect covered by our warranty, the dealer will be contacted for further instructions. Should repairs be made, a purchase order will be issued for said repair, replacement or return of the goods, collect, at an agreed pre-determined cost.
6. Repairs under \$150.00 may be authorized by our distributor if local service is available. Repairs above the amount will require a return authorization number from BLU PUFFIN DESIGNS
7. BLU PUFFIN DESIGNS will not accept any repair, inspection or debit charges, etc, if authorization was not obtained in advance.
